

POLICIES

The following policies govern classes at Muckykids. Please feel free to contact us (617-354-0540 or info@muckykids.com) to discuss any of these policies prior to registering for a class.

Registration Process

- Advance registration is required for all class series. Registration is online.
- For ongoing class series: late registration (joining a class after the series has begun) is possible on a space-available basis prior to the third week.

Fees

- Class/program fee includes all materials.
- Class/program fee is due upon registration and is required in order to guarantee your child's spot.

Cancellation and Refunds

- You may cancel your registration for a class before it begins for a full refund, less a processing fee of \$25.00.
- You may withdraw from an ongoing class after the first week. A refund, less a fee for the class attended and a \$25.00 processing fee, will be given.
- No refund will be given for withdrawal from an ongoing class series after the second class begins.
- If Muckykids needs to cancel a class due to inclement weather or illness, we will attempt to contact you with as much advance notice as possible.
- Classes will continue on Zoom if the State of Massachusetts calls for a shutdown due to a spike in COVID cases.

Parent+Child or Drop-Off

- Generally, classes for age 4 and under are "parent+child" only; stay and get mucky with your little one! Parent+child classes are noted in the class descriptions.
- Classes for older children are drop-off classes. We must have complete contact information for you on your child's registration form.
- For drop-off classes, drop-off begins 10 minutes prior to the scheduled start time.
- Please plan to return at the scheduled end of the class to help your child gather up his or her work and pack up.

Snacks, Allergies, and Wellness

- Muckykids classes do not have snack time.
 Please refrain from eating on site.
- Please do not bring a sick child to the studio.
- If you or your child have COVID, it is mandatory that you refrain from entering the studio. We want to keep everyone healthy!
- Please notify us of any allergies your child has.
